NAME OF CORPORATION

DURATION OF CORPORATION

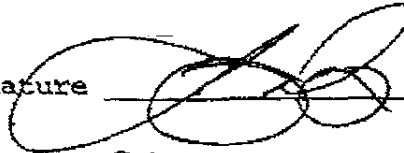
