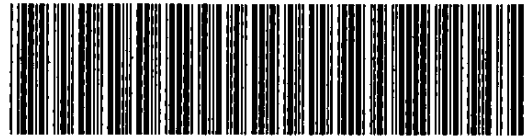

ARTICLE I, NAME OF CORPORATION:

The name of the Corporation shall be:

ARTICLE II, GENERAL NATURE OF THE BUSINESS:

The general nature of the business and the object and purposes to be transacted and carried on are.

To conduct any and all business not prohibited by the Laws of the United States and State of Florida.

To conduct business in, have one or more offices, TATTOOING.

To purchase the corporate assets or any other Corporation and engage in the same or other character of business.

The initial place of business of said Corporation in this State shall be **481 NORTH FEDERAL HWY BOCA RATON, FL. 33432.**

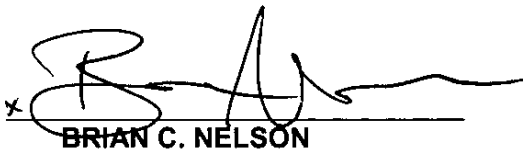

ARTICLE VII, DIRECTORS:

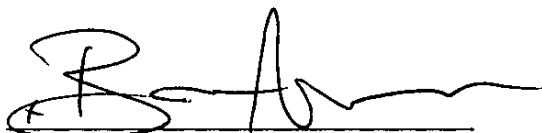
