The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following articles of incorporation for such corporation:

ARTICLE I. NAME AND ADDRESS: The name and address of the corporation is: MARKETMAX INTERNATIONAL, INC., 2947 S. Atlantic Avenue, Unit 805, Daytona Beach Shores, FL 32118.

ARTICLE II. TERM OF EXISTENCE: The period of its duration is perpetual.
