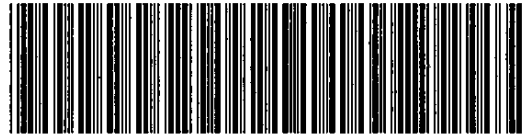

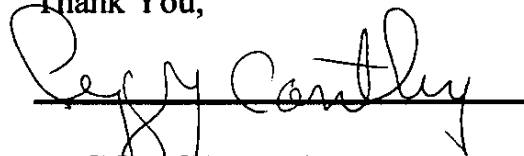

ARTICLES OF INCORPORATION

ARTICLE I- NAME AND PRINCIPAL PLACE OF BUSINESS

The name of this corporation is **AIM JANITORIAL SERVICE, CORP.** and its principal place of business shall be located at **P.O. Box 142, Auburndale, FL 33823.**

ARTICLE II- DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

ARTICLE III-PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV- CAPITAL STOCK

This corporation is authorized to issue **100** shares of common stock, with an assigned value of \$1.00 per share and shall designated as Common Shares.

ARTICLE V- PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation shall have the right to purchase his pro-rata share thereof, (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

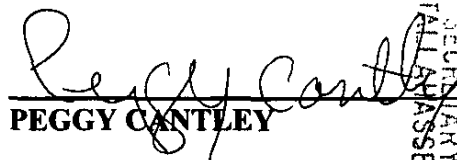
