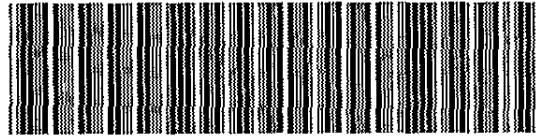

ARTICLE VI- REGISTER AGENT

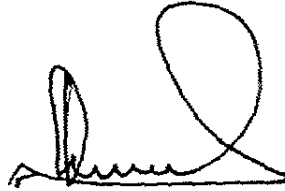

The persons named initial directors shall hold office for the first year of existence of the Corporation or until their successors are elected or appointed and have qualified, whichever occur first.

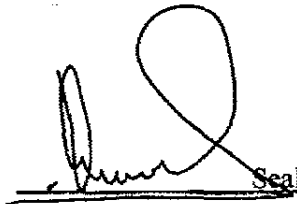
