# ARTICLES OF INCORPORATION OF GOD PLUS ONE, INC.

The undersigned do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

#### ARTICLE 1 - NAME AND ADDRESS

The name of this corporation is God Plus One, Inc. and the address is 14341 S.W. 35<sup>th</sup> Street, Miramar, FL 33027

#### ARTICLE II- PURPOSE

This corporation is organized for the purpose of:

- 1. Political Consulting
- 2. Tourism
- 3. Event Planning
- 4. Transacting any and all lawful business for which a corporation may be incorporated under Florida Statues.

#### ARTICLE III - CAPITAL STOCK
