The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation

Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation shall be: **HIGGINBOTHAM AGENCY, INC.**

ARTICLE II: PRINCIPAL OFFICE

ARTICLE III: EXISTENCE AND DURATION

This corporation shall exist perpetually commencing on August 03, 2006.

ARTICLE IV: PURPOSE

This corporation is organized with the general powers named in Chapter 607, Florida Statutes,

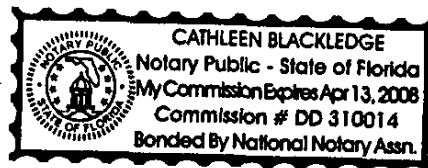


