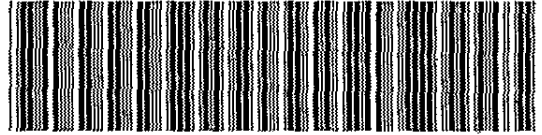

ARTICLES OF INCORPORATION

FOR

**SUMMER BROOK, INC.**

The undersigned, acting as incorporators for this business corporation pursuant to Chapter 607 of the Florida Statutes, hereby form a Business Corporation under the laws of the State of Florida and adopt the following Articles of Incorporation for such corporation.

ARTICLE I

NAME OF CORPORATION

The name of the corporation shall be **SUMMER BROOK, INC.**

ARTICLE II

TERM OF EXISTENCE

This corporation shall begin its corporate existence as of the 1 day of August, 2006, and shall exist perpetually.

ARTICLE III

GENERAL PURPOSE

The general purpose for which this corporation is organized shall be the conduct of creating art and related sales and other services and all things in connection therewith that are related under the laws of the State of Florida. The business of the corporation shall be limited to the foregoing activities.

ARTICLE IV

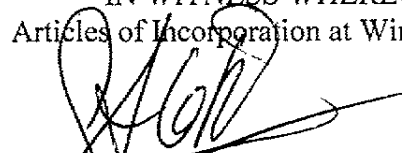
ARTICLE VII

The corporation shall indemnify any incorporator, officer, director, or any former incorporator, officer, or director, to the full extent permitted by law.

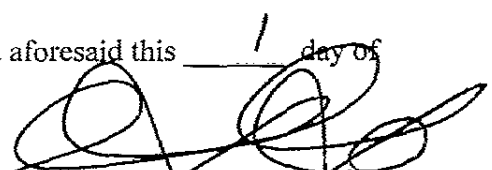
