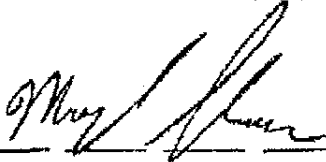

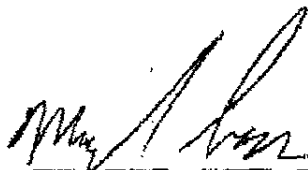
**ARTICLE VIII- INDEMNIFICATION**
