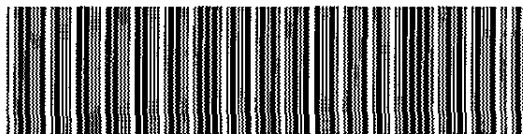

## ARTICLE VIII

### INDEMNIFICATION
