The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the Corporation is Best Florida Realty Services, Inc. Principal place of business is 18840 US Highway 19 North, Suite 440, Clearwater, Florida 33764

ARTICLE II: DURATION

The existence of the Corporation shall commence with the filing of these Articles. The duration of the Corporation is perpetual.

ARTICLE III: PURPOSE

The Corporation may engage only in the licensed financial services activity or business permitted under the laws of the United States and the State of Florida. The purpose is real estate.

ARTICLE IV: SUBCHAPTER S CORPORATION
