**ARTICLES OF INCORPORATION

In compliance with the requirements of Chapter 607, Florida Statutes, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a Florida business corporation.

ARTICLE I

Name

The name of the Corporation shall be JD SPORTS PERFORMANCE TRAINING, INC.

ARTICLE II

Purpose

The Corporation shall have the power to engage in any lawful business.

ARTICLE III

Effective Date

These Articles of Incorporation shall be effective on August 8, 2006.

ARTICLE IV

Principal Office

ARTICLE V

Shares

The maximum aggregate number of shares that the Corporation shall have authority to issue and to have outstanding at any one time is 1000 shares of Common Stock. Common shares shall be the only class of shares which the Corporation shall have authority to issue.

The affairs of the Corporation shall be administered by the officers as designated in the Bylaws. No stockholder shall do any act (including the sale or transfer of such stockholder's stock) which shall contravene or revoke the Corporation's election to be taxed as a S Corporation. All issued shares, excluding treasury shares, and all issued securities evidencing the right to acquire shares of the Corporation shall be held of record by no more than seventy-five (75) persons in aggregate.
