# ARTICLES OF INCORPORATION OF DIAMOND WOOD FLOORS, CORPORATION

Pursuant to and in accordance with the laws of Florida, the following are the Articles of Incorporation of Diamond Wood Floors Corporation.

#### ARTICLE I


#### ARTICLE XII
