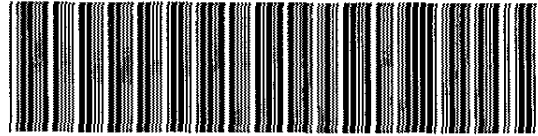

ARTICLES OF INCORPORATION

OF

THE UNDERSIGNED HEREBY MAKE, SUBSCRIBE, ACKNOWLEDGE AND FILE THIS
CERTIFICATE FOR THE PURPOSE OF BECOMING A CORPORATION UNDER THE LAWS OF
THE STATE OF FLORIDA.

ARTICLE I: NAME

The name of this corporation is **POWER EQUIPMENT CONSULTING, INC.**

ARTICLE II: PURPOSE

This corporation will contract with various power companies for advice concerning power
equipment and may engage in any activity or business permitted under the laws of the United
States and of the State of Florida.

ARTICLE III: CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have
outstanding at any time is 100 Shares of Stock of common stock of Ten and NO/100 (\$10.00)
Dollars per share par value.

ARTICLE IV: DURATION

This corporation is to exist perpetually.




