CAPITAL STOCK

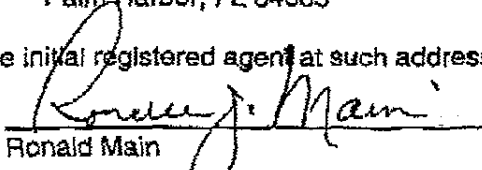

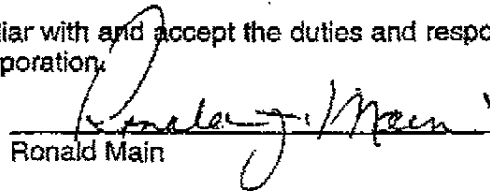
