ARTICLES OF INCORPORATION NATIONAL RECYCLING, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLEI NAME

The name of the corporation is National Recycling, Inc. (the "Corporation").
