**ARTICLES OF AMENDMENT OF
THE ARTICLES OF INCORPORATION
OF
RIVER CITY MEDICAL ASSOCIATES, INC.**

A. The name of the corporation is River City Medical Associates, Inc. (the "Corporation").

B. The Articles of Incorporation of the Corporation were filed with the Florida Secretary of State on August 10, 2006.

C. An amendment to the Articles of Incorporation was adopted on October 26, 2010, by the sole shareholder and the Board of Directors of the Corporation to amend (i) the PREAMBLE, (ii) ARTICLE II – GENERAL PURPOSES, (iii) ARTICLE III – PRINCIPAL OFFICE, (iv) ARTICLE V – INITIAL REGISTERED OFFICE AND REGISTERED AGENT, and (v) ARTICLE VII – CAPITAL STOCK of the Articles of Incorporation in their entirety to read as follows:

"The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:"

"ARTICLE II – GENERAL PURPOSES

The purpose for which this Corporation is organized is to conduct any and all lawful business."

"ARTICLE III – PRINCIPAL OFFICE

The principal office of the corporation in the State of Florida is 6947 Merrill Road, Jacksonville, Florida 32277."

"ARTICLE V – REGISTERED OFFICE AND REGISTERED AGENT

The name and address of the registered agent is Vipul R. Patel, 5924 Covered Creek Lane, Jacksonville, Florida 32277."

"ARTICLE VII – CAPITAL STOCK

The number of shares of stock that this Corporation is authorized to have outstanding at any one time is one million (1,000,000) shares of common stock."
