

ARTICLE I - NAME

The name of the corporation is All Star Tire Company of Brevard, Inc., at 4371 Dixie Highway, Palm Bay, FL 32905 (Principal Office of Registered Agent).

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.

ARTICLE VIII - INITIAL BOARD OF DIRECTORS


