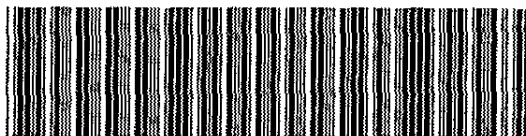

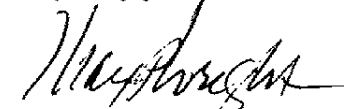

ARTICLE I - NAME

The name of this corporation is **Masterpiece Designs, Inc.**

ARTICLE II - DURATION

This corporation shall exist perpetually.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

In addition to, and not in limitation of other powers conferred by the laws of the State of Florida, this corporation shall have authority to engage in business for the rendition of artistic services including but not limited to the production of art of all descriptions, visual photos, paintings, graphic art works; screen prints; etc.
