TDP Inc., a Florida corporation (the "Corporation"), hereby certifies, persuant to and in accordance with Section 607.1006 of the Florida Business Corporation Act (the "Ant"), for the purpose of filing its Articles of Asserdment to the Amended and Resulted Articles of Incorporation (the "Amended Articles") with the Department of State of the State of Florida, that:

- 1. The name of the Corporation is TDP Inc. . .
- 2. The Corporation's Articles of Incorporation are hereby amended to increase the number of shares designated at Series A Participating Convertible Preferred Stock by deleting the phrase "Seven Handred Thousand (700,000) shares" that in the second paragraph of Article IV section B and replacing it with the phrase "One Million One Hundred Thousand (1,100,000) shares."
- 3. The Amended Articles were adopted and approved on Jestsary 8, 2007 (i) by a unanimous written consent of the diseases of the Corporation and (ii) by a written consent of the holders of a majority of the constanting shares of common stock and of Series A Participating Convertible Preferred Stock of the Company.
