**ARTICLES OF AMENDMENT
TO THE
AMENDED AND RESTATED ARTICLES OF INCORPORATION
OF
TDP INC.**

TDP Inc., a Florida corporation (the "Corporation"), hereby certifies, pursuant to and in accordance with Section 607.1006 of the Florida Business Corporation Act (the "FBCA"), for the purpose of filing its Articles of Amendment to the Amended and Restated Articles of Incorporation (the "Amended Articles") with the Department of State of the State of Florida that:

1. The name of the Corporation is TDP Inc.
2. The Corporation's Articles of Incorporation are hereby amended to change the Corporation's name from "TDP Inc." to "Zave Networks, Inc."
3. Article One of the Corporation's Amended and Restated Articles of Incorporation is hereby amended to read in its entirety as follows:

**ARTICLE ONE
NAME**

The name of the Corporation is Zave Networks, Inc.

4. The Amended Articles were adopted and approved on August 29, 2008 (i) by a unanimous written consent of the directors of the Corporation and (ii) by a written consent of the holders of a majority of the outstanding shares of common stock, Series A Participating Convertible Preferred Stock and Series A-1 Participating Convertible Preferred Stock of the Corporation pursuant to Section 607.0704 of the FBCA (the number of votes cast for these Amended Articles was sufficient for approval by the shareholders). The Amended Articles shall be effective upon filing with the Department of State of the State of Florida.

IN WITNESS WHEREOF, the Corporation has caused these Articles of Amendment to the Amended and Restated Articles of Incorporation to be executed by a duly authorized officer of the Corporation as of this 29th day of August, 2008.
