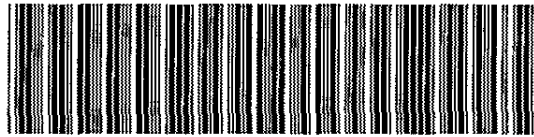

**ARTICLE ONE
CORPORATE NAME**

The name of the corporation shall be:

Jason P. Manchester, D.M.D., P.A.

**ARTICLE TWO
DURATION**

The term of existence of the corporation is perpetual.

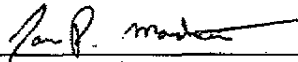

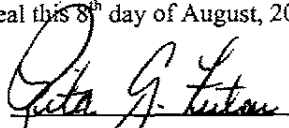

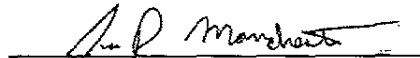
