ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of TREASURE DIVERS TV, INC. under the Floriday Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is TREASURE DIVERS TV, INC.

ARTICLE II. ADDRESS

The mailing address of the corporation is 5151 Collins Avenue, #536, Miami Beach, Florida 33140.

ARTICLE III. COMMENCEMENT OF EXISTENCE
