AMENDED AND RESTATED
CERTIFICATE OF INCORPORATION
OF
INNOTECH SECURITY, INC.
(A Florida Corporation)

Pursuant to the provisions of Section 607.1007 of the Florida Business Corporation Act, the undersigned hereby adopts the following Amended and Restated Articles of Incorporation:

1. The name of the corporation is Innotech Security, Inc. (the "***Corporation***"). The Corporation was originally incorporated under the name Extreme Digital Video, Inc. The date of filing of the original Articles of Incorporation with the Secretary of State was August 14, 2006, as amended from time-to-time thereafter. The document number assigned to the Corporation by the Florida Department of State is No.: P06000106110.

2. The Amended and Restated Articles of Incorporation were duly adopted by the Board of Directors and the sole shareholder of the Corporation on December 29, 2016 in accordance with Section 607.1003, 607.1006 and 607.1007 of the Florida Business Corporation Act.

3. The Articles of Incorporation are hereby amended and restated in their entirety as follows:

ARTICLE I
NAME OF CORPORATION

The name of the corporation is Innotech Security, Inc.

ARTICLE II
ADDRESS OF CORPORATION

ARTICLE III
PURPOSE

The nature of the business or the purpose to be conducted or promoted is to engage in any lawful act or activity for which corporations may be organized under the Florida Business Corporation Act.

ARTICLE IV
CAPITAL STOCK

The total number of shares of stock which the corporation has authority to issue is 10,000 shares of Common Stock, with a par value of \$0.01 per share.

ARTICLE V
