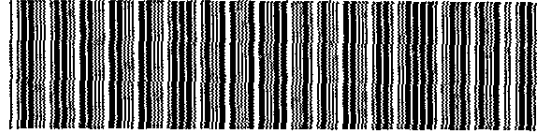

In compliance with the requirements of F.S. Chapter 607 and/or 621, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the corporation ("Corporation") is: **ROOFSKAPES, INC.**

**ARTICLE II**

The existence of the corporation shall begin on the date on which these Articles of Incorporation are first filed with the Department of State of Florida and shall be perpetual thereafter. The purpose for which this corporation is organized is to engage in all aspects of roof painting.

**ARTICLE III**

**ARTICLE IV**
