THE UNDERSIGNED SUBSCRIBER (INCORPORATOR) to these Articles of
Incorporation, desiring to organize a corporation for the purposes hereinafter stated, pursuant to the
Laws of the State of Florida, hereby certifies as follows:

ARTICLE I - NAME

The name of this corporation is ONE SIX THREE, INC.

ARTICLE II - DURATION

This corporation is to exist perpetually.

ARTICLE III - PURPOSE

This corporation may engage or transact in any or all lawful activities or business permitted
under the Laws of the United States, the State of Florida, or any other state, country, territory, or

This corporation is authorized to issue Five Hundred (500) shares of One (\$1.00) par value
common stock.

ARTICLE XII - SHAREHOLDER AGREEMENT

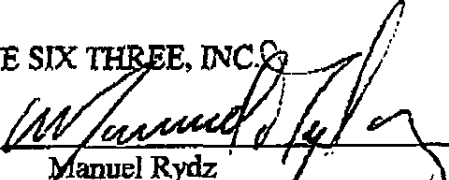

ARTICLE XII - AMENDMENT

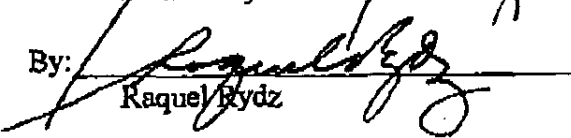

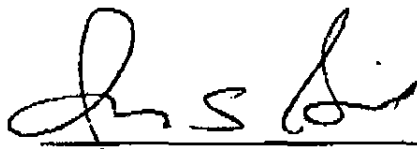
