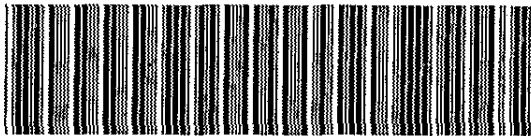

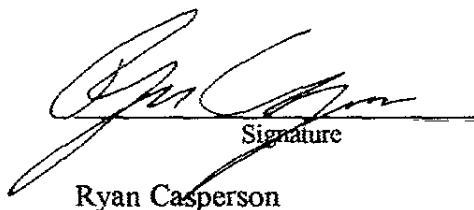
Article VI Nature of Business
