NEW CORPORATE NAME:

AMENDMENTS ADOPTED:

A new Article IX shall read as follows:

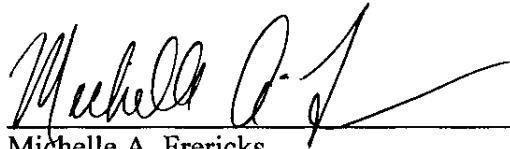
"The purpose for which this Corporation is organized shall be for the sale of real estate and related real estate activities."

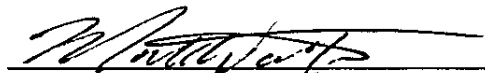
