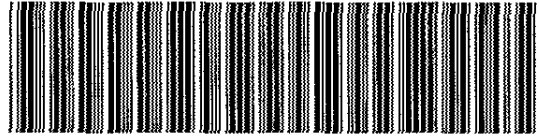

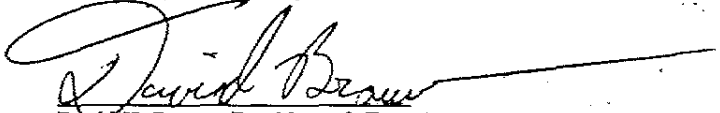

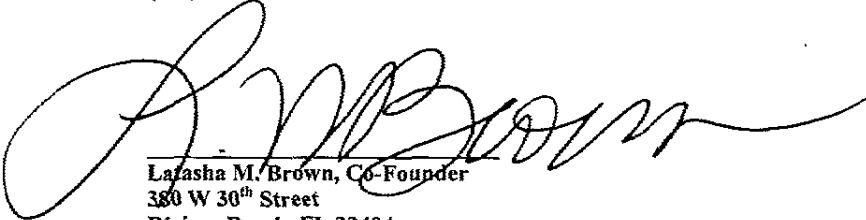

The Articles of Incorporation of

In Compliance with Chapter 607 and/or Chapter 621, F.S. (Profit)

The undersigned, for the purpose of forming a for-profit corporation under the laws of the state of Florida, do hereby adopt the following Articles of Incorporation.

ARTICLE I
NAME

The name of the corporation shall be **F.A.I.T.H. Management Financial Services, Inc.** (hereinafter called the "Corporation").

ARTICLE II
PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office and mailing address of the corporation is **380 W 30th Street, Riviera Beach, Florida 33404.**

ARTICLE III
PURPOSE

The Corporation is a for profit organization organized for the purpose of engaging in any lawful act or activity for which for profit corporations may be organized, so for as is in or may be permitted by the laws of the state of Florida. The specific purpose of the Corporation is to provide the following services: Financial Advisor, Credit Restoration, Budget Workshops, Budget Planning, Banking Finances, Notary Services, Business/ office Management, etc.

ARTICLE IV
CAPITALIZATION
