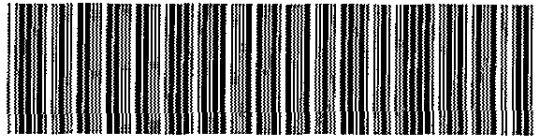

ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is Balance Investments Corp.

ARTICLE II - PRINCIPAL OFFICE
