WE, the undersigned, do hereby associate ourselves together for the purpose of becoming incorporated under Florida Statutes, We respectfully petition the Secretary of State for the approval of such incorporation, and for such purpose We hereby make, execute, and adopt the following Articles of Incorporation:

ARTICLE I

NAME AND PLACE OF BUSINESS

The name of this corporation shall be: **HARRIS & SAMPLE ENTERPRISE, INC.**, and its location and business operations shall be conducted as a State of Florida corporation.
