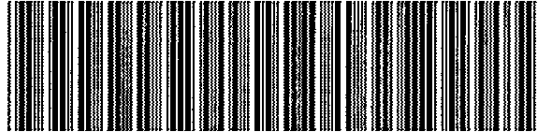

IN ACCORDANCE with the provisions of Section 607.1402 and Section 607.1403, Florida Statutes, the above named corporation hereby files its Articles of Dissolution as follows:

W I T N E S S E T H:

1. The corporation was originally formed on August 17, 2006 under the name of PRODIGY MORTGAGE GROUP, INC. and assigned Document Number P0600107728.

2. Upon a duly called and conducted meeting of all of the Stockholders of the corporation and all of the Directors of the corporation, held on August 25, 2006, a resolution was unanimously adopted and approved that the corporation be dissolved prior to September 1, 2006 and the same was authorized by all Directors and Officers of the corporation.
