# ARTICLES OF INCORPORATION

These Articles of Incorporation are adopted for the purpose of forming a corporation under the laws of the State of Florida, to be filed with the Florida Department of State, as follows:

#### ARTICLE ONE: NAME

The name of the corporation is UAA Fidu, Inc., and the address of its principal office is 3908 26th St W, Bradenton, FL 34205, until and unless such address is subsequently changed by the corporation.

#### ARTICLE TWO: COMMENCEMENT AND DURATION

The corporation shall commence its corporate existence as of 16 August 2006 and it shall exist perpetually thereafter until dissolved according to law.

#### ARTICLE THREE: PURPOSE
