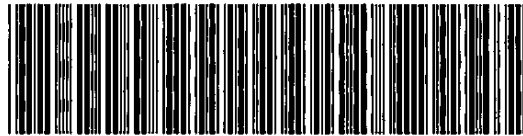



The undersigned, for the purposes of forming a corporation under Section 607.0202 of the Florida Business Corporation Act, does hereby certify as follows:

ARTICLE I

Corporate Name and Address

The name of the Corporation is IOPC, Inc., and the mailing address of the Corporation is 1929 Madera Drive, North Fort Myers, Florida 33903.

ARTICLE II

Corporate Purpose

The Corporation is organized to transact any and all lawful business authorized by the Florida Business Corporation Act.

ARTICLE III

Authorized Stock

The aggregate number of shares of the Corporation shall be 1,000, all of which are to be voting common stock having a par value of \$1.00 per share.

ARTICLE IV

Registered Office and Registered Agent

The street address of the initial registered office of the Corporation in the State of Florida shall be 1929 Madera Drive, North Fort Myers, Florida 33903. The name of the initial registered agent of the Corporation at the registered office shall be Thomas A. Ziegler, Sr.

ARTICLE V

Initial Board of Directors

The initial Board of Directors of the Corporation shall be comprised of one person. The Directors shall be elected annually in accordance with the By-laws. The number of Directors may be increased or decreased from time to time in accordance with the By-laws, but shall never be less than one. Commencement of Existence


The Corporation shall be deemed to commence on the date of filing of the Articles of Incorporation.

The term of existence of the Corporation is perpetual.

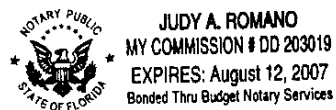
