ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporations Act hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME AND ADDRESS

The name and address of this corporation is SUNNY BOY PRODUCTIONS, INC. The principal place of address is 6601 Lyons Road, Suite #C-4, City of Coconut Creek, Coconut Creek, Florida, 33073

ARTICLE II - DURATION

This corporation shall have perpetual existence, commencing on date of filing of Articles of Incorporation.

ARTICLE III - PURPOSE

The purpose of the Corporation is to engage in the transaction of all lawful business for which corporations may be incorporated under the law of the State of Florida and to exercise the powers now or hereafter granted to Florida Corporations.




