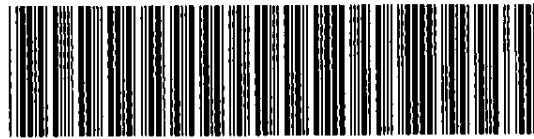

It is resolved: That the name of the corporation has been changed, the new name shall be:


LAKES RADIOLOGY II, INC.
