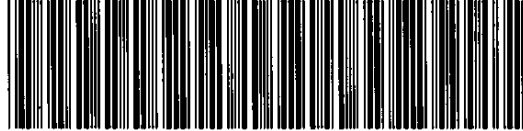

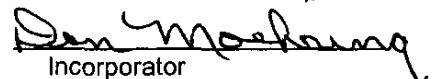
ARTICLE IX AMENDMENTS

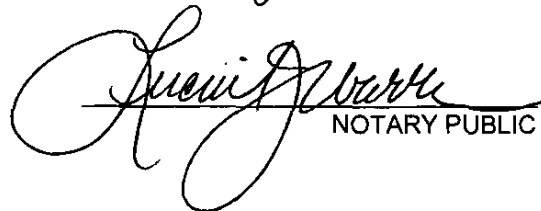
