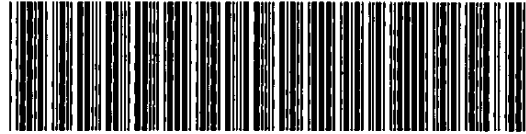

The name of the corporation is: Antina Lee Investments, Inc.


