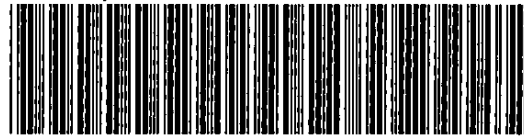

of


