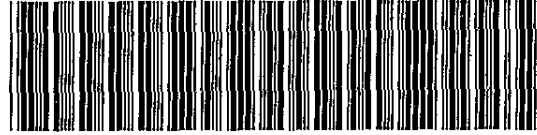

The undersigned, acting as incorporator to these Articles of Incorporation, hereby forms a corporation for profit under the Laws of the State of Florida, Chapter 607 F.S.

**ARTICLE I – NAME.**

The name of the corporation shall be: DAYDREAM TO REALITY, INC.

**ARTICLE II – PRINCIPAL OFFICE & MAILING ADDRESS.**

The principal place of business of the corporation shall be: 1210 Palmer Lane, Palm Harbor, FL 34685. The mailing address of the corporation shall be: 1210 Palmer Lane, Palm Harbor, FL 34685.

**ARTICLE III – PURPOSE.**



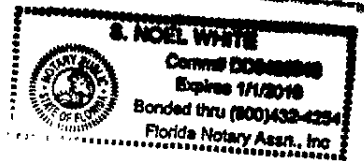
