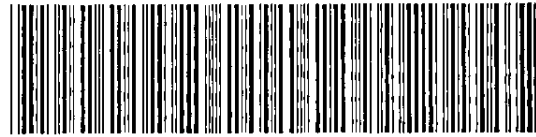



Pursuant to the provisions of Section 607.1006, and pertinent provisions of Chapter 621, Florida Statutes, this Florida professional services corporation adopts the following Articles of Amendment to its Articles of Incorporation, originally filed with the Department of State on August 22, 2006, assigned document number P06000110062, and subsequently amended on December 18, 2009:

1. Article 1 of the Articles of Incorporation as subsequently amended is amended to read:


**ARTICLE 1.
