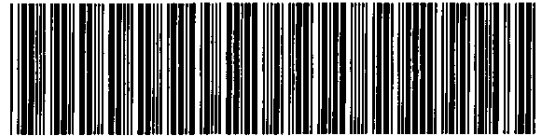



**ARTICLES OF INCORPORATION OF**  
**GEMINI CABINET SERVICES INC.**

*ARTICLE I – NAME and PRINCIPAL PLACE OF BUSINESS*

The name of the corporation is GEMINI CABINET SERVICES INC., and its principal place of business shall be located at 159 Sandpiper Avenue, Royal Palm Beach, Florida 33411.

*ARTICLE II – DURATION*

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

*ARTICLE III – PURPOSE*

This corporation is organized for the purpose of transacting any or all lawful business.
