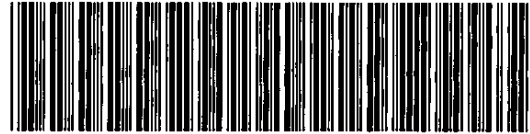

NAME

The name of this corporation ("Corporation") is: G & O MARKETING ENTERPRISES, INC.

ARTICLE II
DURATION

Any director or officer who is involved in litigation or other proceeding by reason of his or her position as a director or officer of this corporation shall be indemnified and held harmless by the corporation to the fullest extent permitted by law.


ARTICLE X OTHER PROVISIONS
