- 5. The 2023 filing wrongly listed the Principal and Mailing Address of the corporation, and the Address of each officer, as 911 Panorama Trail South, Rochester, NY, 14625. The filing also contained an inaccurate EIN Number for the corporation.
- 6. That on or about April 8, 2024, the undersigned Alan S. Walters reported these facts to the City of Miami Police who rendered the Incident Report attached hereto as Exhibit "A".
- Your Affiant has subsequently reviewed the on-line records and discovered that on or about April 15, 2024, a false 2024 Annual Report for ESG Management, Inc was filed with the Division of Corporations.
- 8. The 2024 filing wrongly lists Terrence Sukalski as President/Director, Stephanie Schaeffer as Secretary, and Christopher Simmons as Treasurer of the Corporation.
- 9. The 2024 filing wrongly lists the Principal and Mailing Address of the corporation, and the Address of each officer, as 2054 Vista Parkway, Suite 300, West Palm Beach, Fl., 33411. The filing continues to provide an inaccurate EIN Number for the corporation.

- 10. Neither Eric B. Galbut nor Alan S. Walters authorized the above-described changes to be made, and prior to April, 2024, neither was aware that the changes had been made.
- 11. Neither Eric B. Galbut, Alan S. Walters, or the company's registered agent, Abraham A. Galbut, have met, spoken to, or have had any association with the aforenamed Terrance Sukalski, Stephanie Schaeffe, Robert Schrader, Stephanie Schaeffer, or Christopher Simmons.
