

ARTICLE I: NAME

The name of this corporation shall be Dental Health Staffing, Inc.

ARTICLE II: DURATION

The corporation shall have a perpetual existence.

<u>ARTICLE III: PURPOSE</u>

The purpose of this corporation is to engage in any activity or business permitted by the laws of the State of Florida or the United States of America.

ARTICLE IV: STOCK
