Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:

FIRST:

Amendment(s) adopted:

A. Article IV of the Articles of Incorporation is amended to read as follows:

Articles IV - The corporation shall have two classes of shares. Class A shall consist of 100,000,000 shares of voting stock having a par value of \$0.0001 per share. Each Class A share shall have one vote associated with said share. Class B shall consist of 100,000,000 shares of voting stock having no par value. Each Class B share have 10 votes associated with said share.

B. A new Article IX is added to the Articles of Incorporation as follows:
