WHEREAS, it is the intention of all of the directors and all of the stockholders of MERCATR, INC. that the Articles of Incorporation of MERCATR, INC. be amended in accordance with the proposed amendment hereinafter set forth; and

WHEREAS, the proposed amendment to the Articles of Incorporation of MERCATR, INC. hereinafter set forth was approved by all of the directors and all of the stockholders comprising the only voting group of stockholders of MERCATR, INC., pursuant to the provisions of Florida Statutes, Section 607.1003(5), on the 25 day of October, 2006; and

1. Article I of the Articles of Incorporation shall be amended in its entirety to read as follows:
