The undersigned, acting as incorporator of CAROLINA CONNECTION REALTY, INC., adopts the following Articles of Incorporation to form a for profit corporation under the laws of the State of Florida.

ARTICLE I NAME

 - 2. Any other lawful activity parmitted under the laws of the state of Florida.

ARTICLE VI
