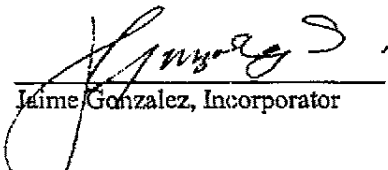
ARTICLE X
