ARTICLE III - PURPOSE

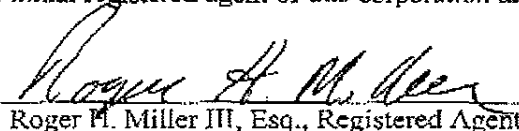
This corporation is organized for the following purposes: To carry on any business permitted under the laws of the State of Florida.

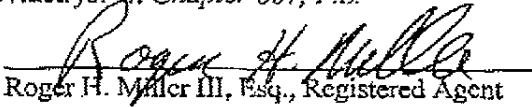
